TOMA has no reserves & £176 in the bank. We have just started as an organisation under director/founder, artist Emma Edmondson (EE), after an incubation period in partnership w/ Metal since Jan 2016. TOMA became a CIC as part of ACE Project Grant funding from & is only 7 months old as an independent organisation. This Project Grant is nearly fully spent on agreed activities, w/ £1,500 final payment, & future funding for the cycle would normally come directly from artist participants, artwork sales, donations & other indefinitely postponed funding. TOMA runs on a shoestring budget to deliver our community focussed art projects. As we now develop solo support is vital in this crucial inception time for us to survive. TOMA was hoping to build reserves up through artwork sales & fundraising - we already raised £2,300 which has been spent on programming - but as TOMA's public space is closed due to COVID-19 & we now need to find new ways to host artwork sales & take donations online.

TOMA is a low cost alternative, accessible art education model for artists & the community in a busy Southend high st art space. We are set up as a low cost model to provide free & affordable quality, critical education to those from low income backgrounds.

TOMA education programme - Artists pay £75p/m to participate in the 12 month programme but many have lost freelance work. 4 artists are struggling & paused fee payments meaning £300 for March income has stopped hitting cash flow. TOMA offered this to support artists facing social/economic barriers, central to our ethos. TOMA continues to support artists online during the crisis w/ video crits/tutorials from EE & freelance artists Morgan Quaintance, Alison Ballard & Susan Stockwell. TOMA continues to pay existing commitments w/ these freelance artists. TOMA artist fees are a primary income & directly pay for the education prog to run; freelance artists for talks/crits/tutorials & support from EE & curator Lolly Adams (LA). Director EE spent time in kind (8 days @ £1,200)/will spend unbudgeted extra days supporting TOMA's 24 artists/rescheduling education & public programme.

TOMA Project Space - Our public art exhibition & workshop space in the centre of the community is shut but freelance artist/curator LA has spent time in kind (6 days @ £900) supporting artists/finding digital avenues/rescheduling public events.

Donations/art sales - (£330 p/m av) TOMA Project Space is shut so no opportunity for donations/art sales.

Expanding collaborations - TOMA had a £15k collaborative funding bid w/ The Old Waterworks (TOW) for exhibition/workshop prog about artist/community survival in precarious times for Estuary 2020. £5k would have been for overheads. This has been postponed.

TOMA received 2 ACE Project Grants over 4 years. TOMA received private funding from supporters including Sarah Lucas, Connor Brothers, Mark Leckey, Seedbed Trust & philanthropists. TOMA has been supported by NPOs Metal, Focal Point Gallery & Chisenhale to deliver projects. TOMA has been commissioned to host public facing projects at Victoria & Albert Museum, Big Screen Southend & Conway Hall. Metal & TOW support TOMA w/ space/time in kind. TOMA works w/ art schools, unis, schools, artist-run & community spaces on projects.

TOMA's 12-month education programme is shaped collaboratively, artist participants decide what is learnt through a public programme, crits, workshops, tutorials, residencies & visiting freelance artists including; Bruce McLean, Chris Kraus, Jade Montserrat, Jeremy Deller, Mark Leckey, Sarah Lucas, Sonia Boyce, Tai Shani.

TOMA has a reputation for quality critical art education & nurturing artists. In a 2018 TOMA artist questionnaire 100% said their practice changed & felt supported to pursue creative ideas/risks as a result of TOMA. We recently launched an artist network where past TOMA artists continue to access learning opportunities. The current programme supports 24 participating artists.

TOMA makes use of empty shops & a much-needed contemporary art space in Southend, TOMA Project Space. This is based in an empty retail unit in the heart of the community of one of the lowest social economic wards in Southend. Since 2018 it has hosted 34 free exhibitions/events & regular public programme of open crits attended by +75 artists. 29 volunteers hosted the space for 624 volunteer hours. We have been open for 40 weeks w/ +5,000 visitors. We invite artist groups to visit bringing Southend new economies & promoting it as a cultural place.

TOMA consists of small team artist/director EE, artist/curator LA & extended artist network. TOMA supports these practitioners through freelance employment, alongside our affordable & free educational/community programme meaning this grant is vital for TOMA & a wider creative community. This grant would enable TOMA to continue to deliver during lockdown ensuring support for this community while shaping ourselves digitally for accessibility, resilience & sustainability. TOMA is currently only applying to this fund as no other will fully cover organisation costs to keep our team going.

TOMA education programme - TOMA wants to continue supporting our artists digitally during COVID w/ crits, tutorials & sessions online. TOMA wants to ensure artists do not suffer & continue to get quality, critical education. During COVID TOMA has supported our artists w/ digital video crits on Zoom. These are popular & necessary to ensure TOMA participants stay connected. TOMA wants to expand this digital strategy w/ extended group of 75 artists engaged w/ our existing public open crit programme. This fund would help expand new ways of working, support artists through TOMA's methods & ethos while keeping momentum & support w/in this creative community helping us survive.

TOMA Project Space - We want to commit to continuing the public programme digitally where possible keeping momentum for this busy, popular space. TOMA wants to employ x2 disabled artists Bella Milroy & Hannah Devereux who we have worked w/ previously to deliver digital workshops in response to COVID & our current show from Essex artist Karen Wilcox (KW). This show, open only 2 days before shutting down, features work from KW who is mainly housebound due to disability. Her central theme is, ironically, isolation.

### (Up to a further 1,000 characters if needed)

We have been releasing texts around isolation & accessibility from KW online since then & would like to continue this. Accessibility is central to TOMA's ethos & we see this as beneficial to support us to continue working in this way. This grant will support organisational running costs of the space employing LA to reschedule programme & cover insurance/overheads to ensure we keep the space in kind.

Expanding collaborations – This grant will support development activity w/ TOW, in lieu of lost £15k funding, to plan & get ready to restart in a more collaborative way & find new avenues for our public project on survival.

Donations/art sales - As TOMA Project Space is closed we will commission 12xTOMA artist print editions to sell online to support themselves & TOMA during this time. We will also support artist KW to release x 2 prints. TOMA will split sales 50/50 w/ artists exchanging our real life shop for an online one moving business forward w/ future fundraising models.

This fund will help TOMA continue w/ our programme of free workshops digitally via video to artists & wider community. Affordability is central to TOMA & continuing free workshop ops ensures everyone can be creative people via TOMA. Staying connected to our audiences digitally will support the continuation of the public art programme in our busy high street space once safe to do so. TOMA has a great relationship w/ landlord who pays business rates & waivers rent, they want to support TOMA to continue dissolving barriers between artists/public w/ our shows surrounding relatable themes (eg recent show Pets) & activities that get people to create adding to a creative & cultural country.

Expanding collaborations - R&D time w/ TOW will mean both orgs are more robust & sustainable through continuing to share resources & relationships. This tighter collaborative working with TOW, also artist-led, will support creative practitioners & art eco-systems in this cultural community in times of economic hardship.
